An Advertisement for recruitment to the post of Consulting Executive in Jharkhand State Pollution Control Board on contract basis was published in leading newspapers vide PR 213269 dated 01.08.2019. After scrutiny and short listing of applications a total of 115 applicants were declared eligible, 25 were declared not eligible and 19 were declared disqualified.
